

## Community Health Worker/ Promotor de Salud Job Description

*A community health worker is a trusted member of and/or has an unusually close understanding of the community served. This trusting relationship enables the worker to serve as a liaison/link/intermediary between health/social services and the community to facilitate access to services and improve the quality and cultural competence of service delivery.*

*A community health worker also builds individual and community capacity by increasing health knowledge and self-sufficiency through a range of activities such as outreach, community education, informal counseling, social support and advocacy.*  
(APHA definition)

**Title:** COVID19 Community Health Worker/ Promotor de Salud

**Reports to:** COVID19 Project Leaders / Assigned Department Manager

**Hours:** Flexible, 30 - 40 hrs per week

**Pay Rate:** \$20 / hr

### Duties/ Responsibilities

Under the leadership of the COVID19 Project Leader and/or the assigned Department Manager, the COVID19 Community Health Worker/Promotor provides outreach, education, and support to community members. Outreach and education efforts focus on COVID19, testing, vaccination, and other topics that may help community members recover from the impact of COVID19. CHW/P also help advocate for issues and inform service/policy improvements.

Candidates for this position must:

- Be part of and be well connected within the community
- Be knowledgeable of Latinx culture and issues affecting the community
- Have strong oral and written Spanish and English skills
- Have working knowledge of use of computers, ipad, Microsoft, google suites, etc.
- Have knowledge of CVMS, NC CARE360 and other similar platforms or be able to complete training to use these platforms within 30 days of employment
- Be creative, social, energetic, outgoing, flexible, self-motivated, detail-oriented, respectful, and able speak with a diverse group of people with various literacy levels one-on-one or in large group settings
- Have a car/driving license or reliable mode of transportation
